Due to the fact that inline hockey is played in a wide variety of facilities, it is necessary for BCIHA to sanction only those leagues that operate in a safe and organized manner. ## League Sanction Procedures

- ◆ Complete all sections of this agreement
- ◆ League sanctioning agreements should be submitted to British Columbia Inline Hockey Association no later than **MARCH 1st, 2010.**
- ◆ Submit completed sanctioning agreement to the BCIHA office on or before the above mentioned date.
- ◆ Include all additional required information, such as; rental agreements, facility photographs etc.
- ◆ Certificate of Insurance Request Form: Completion of this document with all appropriate signatures and dates will ensure full insurance coverage and benefits with NIHA - Canada. Return this form via Fax, Email or Regular Mail as soon as possible. A certificate of Insurance coverage will then be returned to your league.

## BCIHA CODE OF CONDUCT



This Code for Conduct identifies the standard of behavior which is expected of all BCIHA members and participants, which for the purpose of this policy shall include all players, guardians, parents, coaches, officials, volunteers, directors, officers, committee members, conveners, team managers, trainers, administrators and employees involved in BCIHA activities and events.

BCIHA is committed to providing an environment in which all individuals are treated with respect. Members and participants of BCIHA shall conduct themselves at all times in a manner consistent with the values of BCIHA which include fairness, integrity and mutual respect.

During the course of all BCIHA activities and events, members shall avoid behavior which brings BCIHA or the sport of hockey into disrepute, including but not limited to abusive use of alcohol, use of non-medical drugs and use of alcohol by minors.

BCIHA members and participants shall at all times adhere to BCIHA's operational policies and procedures, to rules and regulations governing BCIHA events and activities, and to rules and regulations governing any competitions in which the member participates on behalf of BCIHA.

Members and participants of BCIHA shall not engage in any activity or behavior which interferes with a competition or with any player or team's preparation for a competition, or which endangers the safety of others.

Members of BCIHA shall refrain from comments or behaviors which are disrespectful, offensive, abusive, racist or sexist. In particular, behavior which constitutes harassment or abuse will not be tolerated, and will be dealt with under BCIHA's Harassment policy.

Failure to comply with this Code of Conduct may result in disciplinary action in accordance with the Discipline Policy of BCIHA. Such action may result in the member losing the privileges which come with membership in BCIHA, including the opportunity to participate in BCIHA activities and events, both present and future.

### REGISTRATION POLICIES AND TIMELINES

**January** – Leagues to receive League Package & CD from NIHA-Canada. This will include a CD of all documents required for the 2010 season, Calendar of Events, information from Sponsors/Suppliers.

**March 1<sup>st</sup>** – Deadline for Leagues to submit League Registration Forms to Provincial Branches.

**March 15<sup>th</sup>** – Deadline for Provincial Branches to submit League Registration Forms to NIHA-Canada. Any new league registering after this date may do so, however, the Provincial Branch will be responsible for collecting and submitting fees to NIHA-Canada.

**April 1<sup>st</sup>** – All Certificates of Insurance to be sent to leagues by NIHA-Canada.

**May 15<sup>th</sup>** – All Registration Lists (Player and Officials) to be submitted to Provincial Branches in accepted format. Any league not complying with this will NOT have insurance coverage from May 15<sup>th</sup> until the day this list has been received by Provincial Branch.

**June 1<sup>st</sup>** – All payment from leagues must be submitted to Provincial Branches. Any league not complying with this will NOT have insurance coverage from June 1<sup>st</sup> until the day this payment has been received by Provincial Branch.

Provincial Registration List to be submitted to NIHA-Canada. Any Branch not complying with this will NOT have insurance coverage from June 1st until the day this list has been received by NIHA-Canada.

**June 15<sup>th</sup>** – Payment from Provincial Branches must be submitted to NIHA-Canada. Any Branch not complying with this will NOT have insurance coverage from June 15<sup>th</sup> until the day this payment has been received by NIHA-Canada.
